The timber was inventoried in February 2023 by FORECON, Inc. and shows a volume of approximately 226,116 boardfeet, Doyle log rule, dominated by red oak. The inventory was only completed on the north side of the road as timber is more prevalent there than on the south portion. The south portion has a great mix of larch, spruce, red pine, oak maple, some old apple orchard and more. The abundance of deer trails and feeding areas is easy to see.

The property adjoins public land on the south boundary that combines with other public lands to provide over 1,000 acres of additional land for your recreational pleasure.

There is over 1,500 feet of frontage on both sides of Coss Corners Road and electric is available along road front.

All timber and surface rights transfer. As this is a former Seneca Resources property, all the oil, gas and mineral rights are previously reserved by them and do not transfer.






