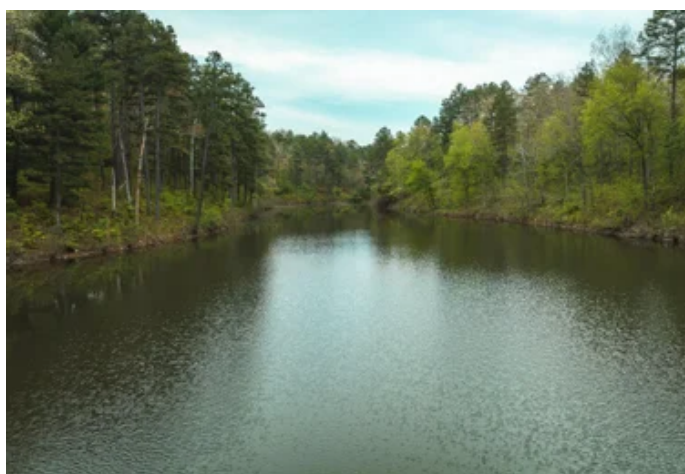

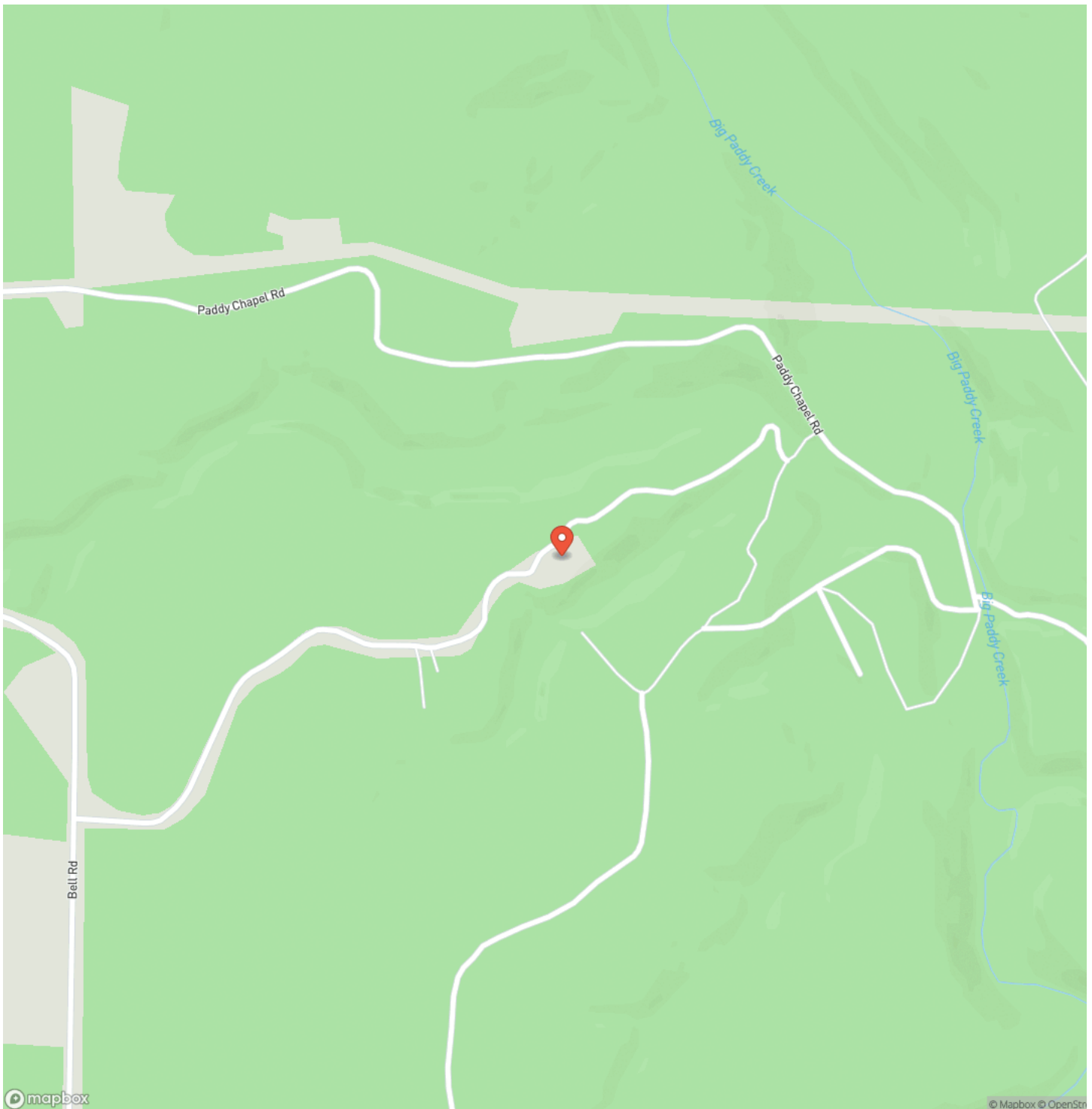

Locator Map

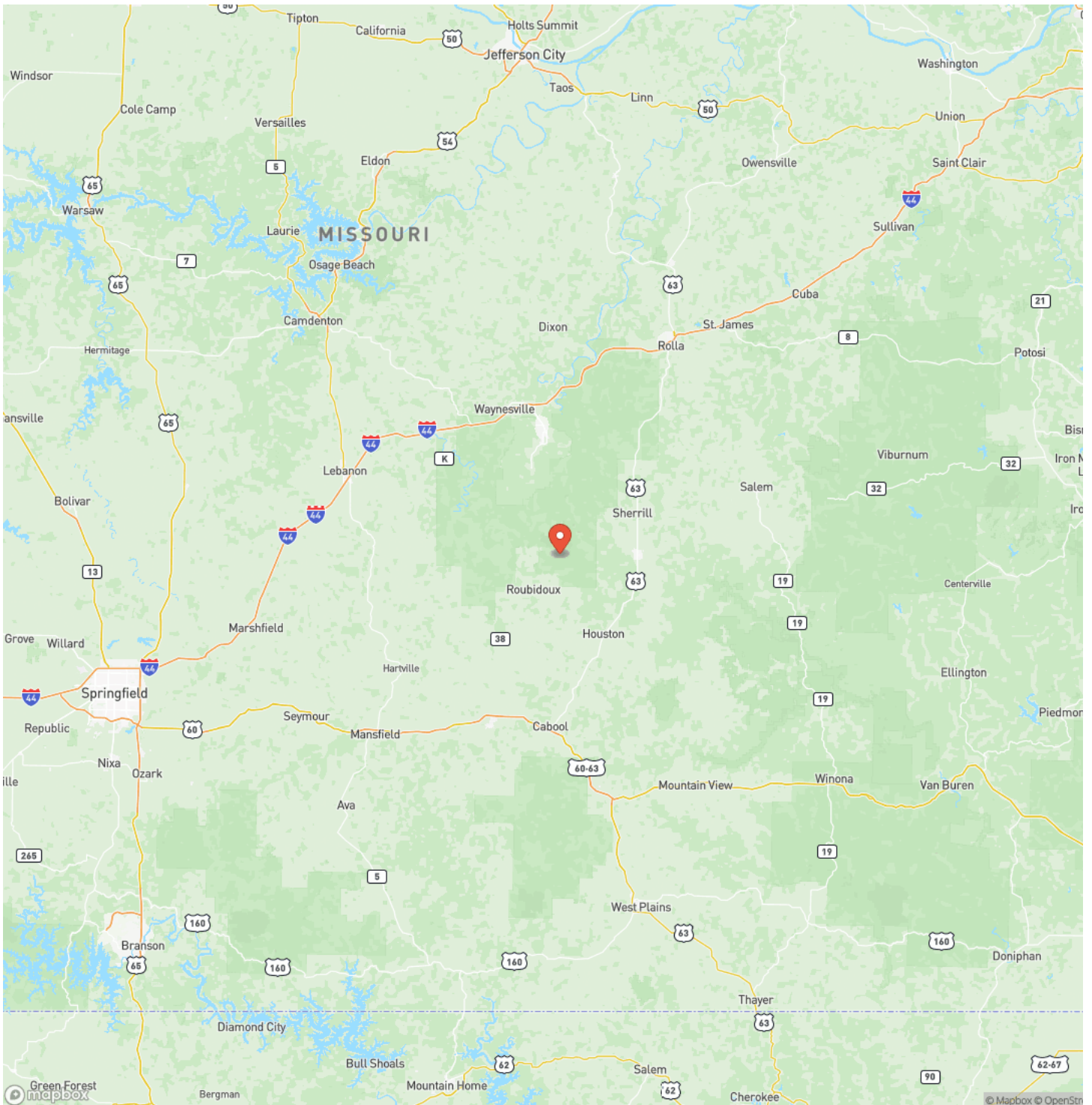

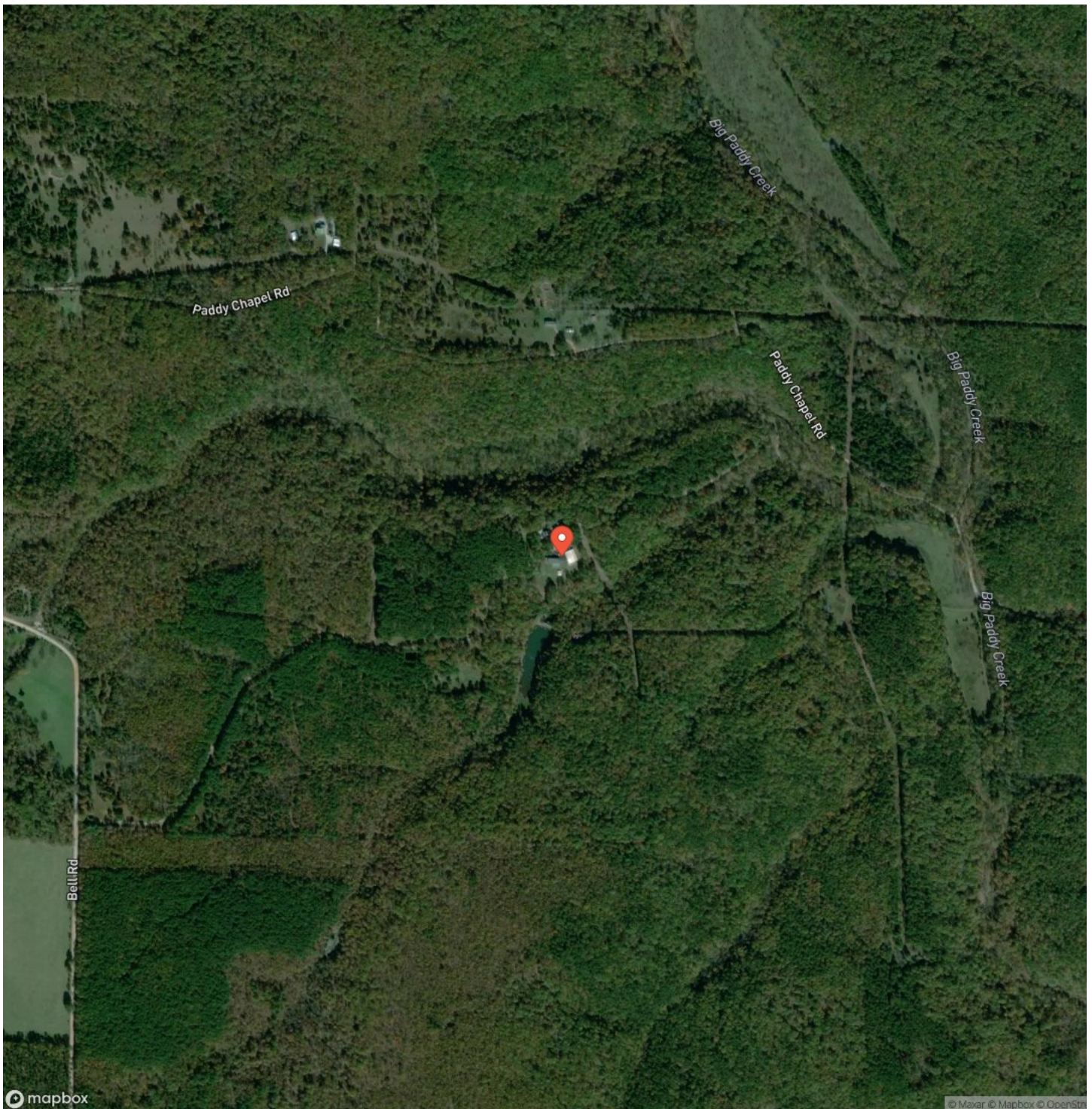
