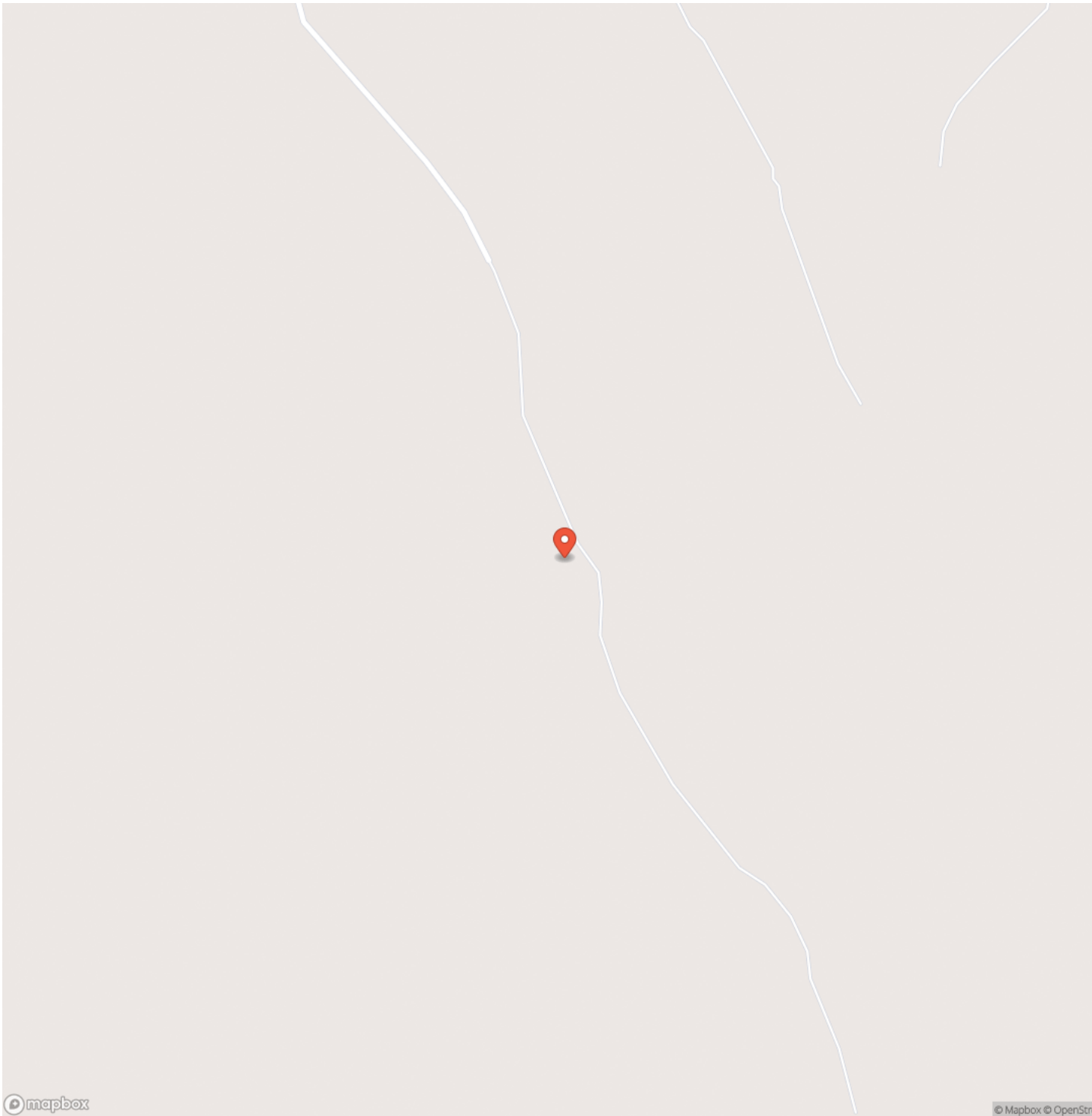




Whitetail Ridge
