

Located on the outskirts of Cassel, well known for access to Hat Creek, a trout-fishing destination. Baum Lake, open year-round to fishing, is just a few miles up the road. You will also find Burney Falls State Park, Lake Britton, and Pit River within a few miles. Burney and Fall River Mills are within 10-15 miles, offering all the benefits of rural living, in addition to the 18-hole Fall River Golf Course.











Locator Map


Locator Map
