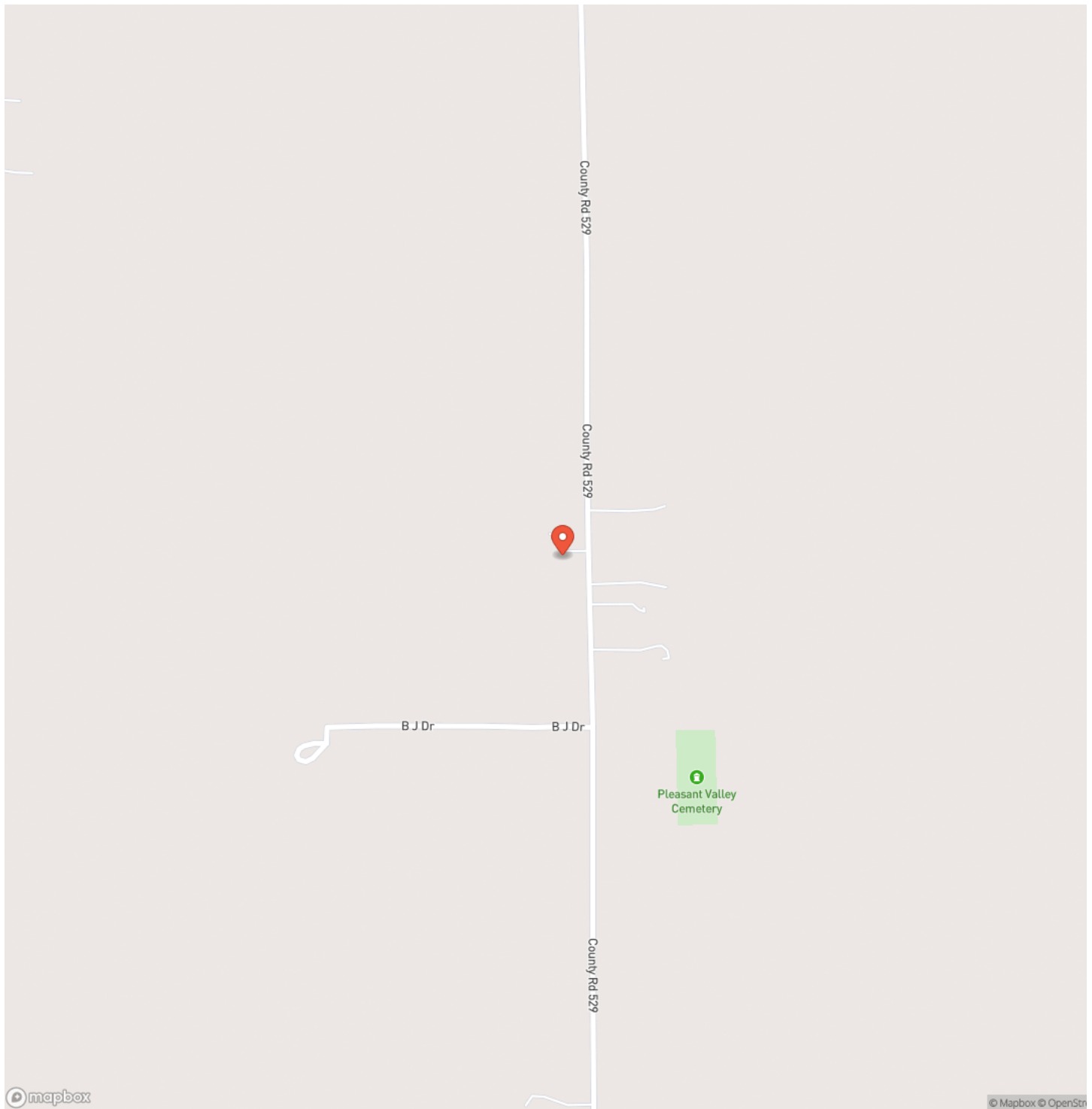

Locator Map

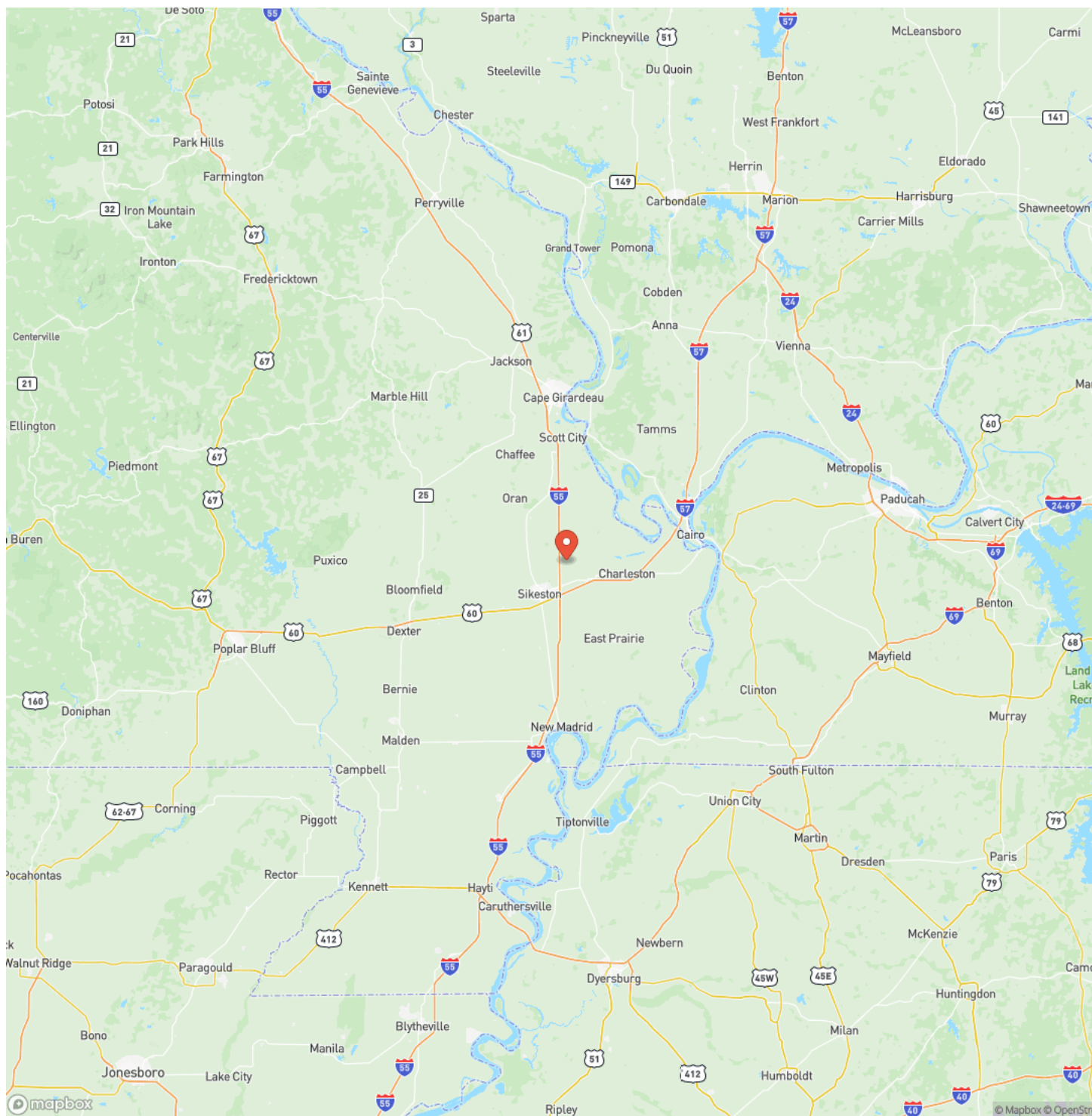
