Beyond the house, a chicken coop with a solar-timed door simplifies egg collection, and an extra foundation sets the stage for future expansion. Additional amenities include a woodshed with a stove, a tack shed for equine equipment, a run-in shelter, two hay barns, and a well house. 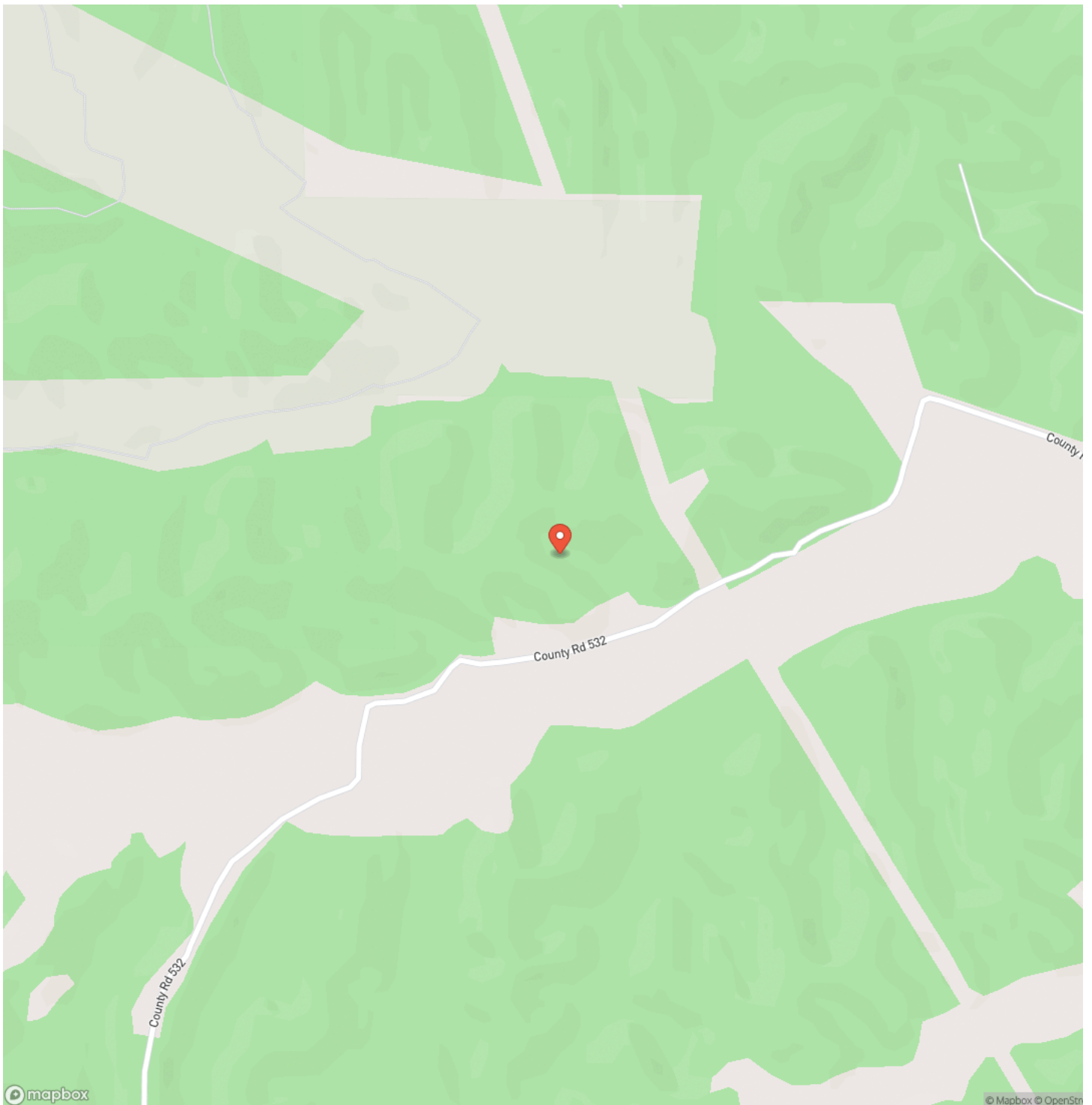

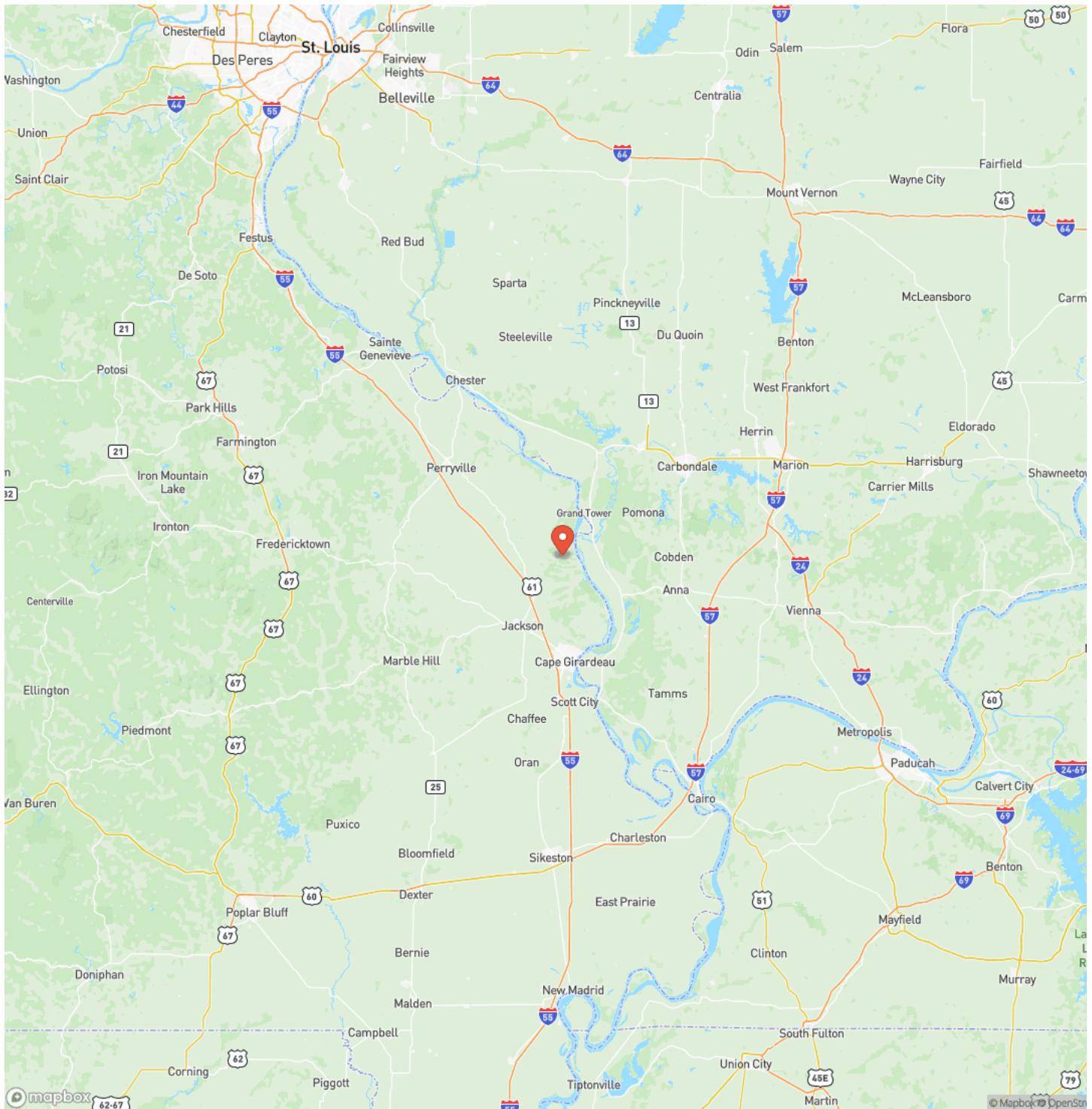
Locator Map
