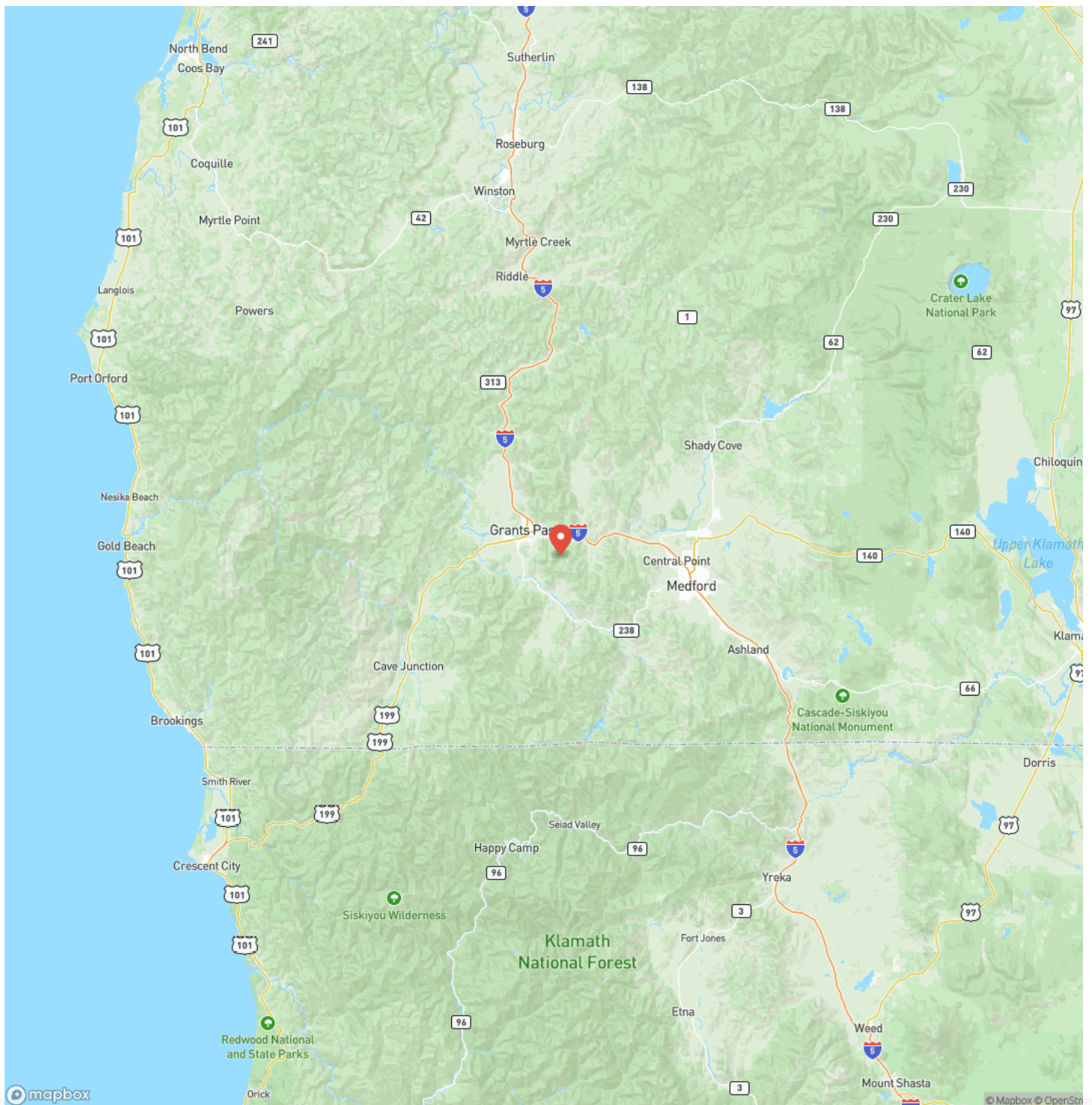




Locator Map
