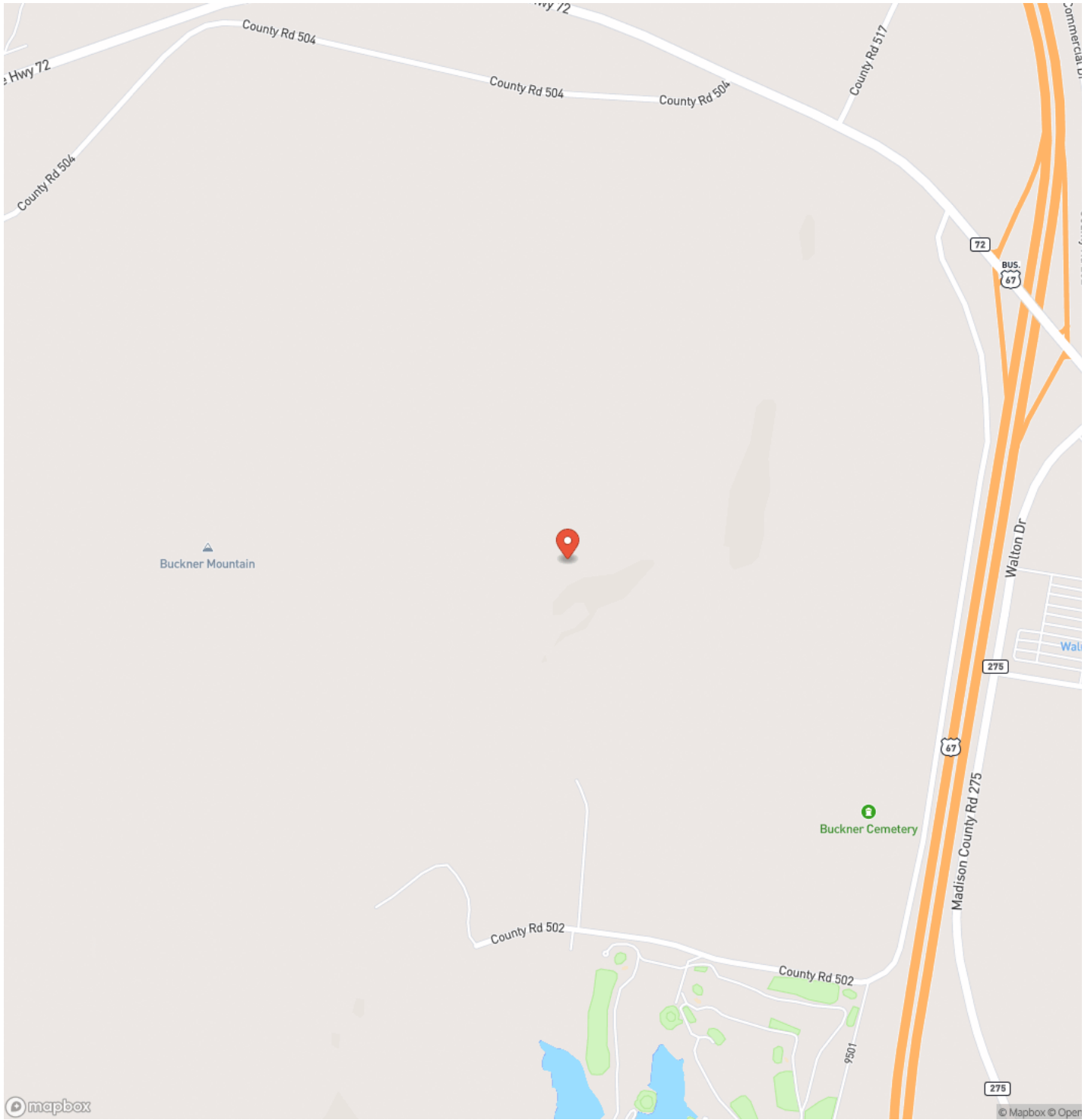

Locator Map

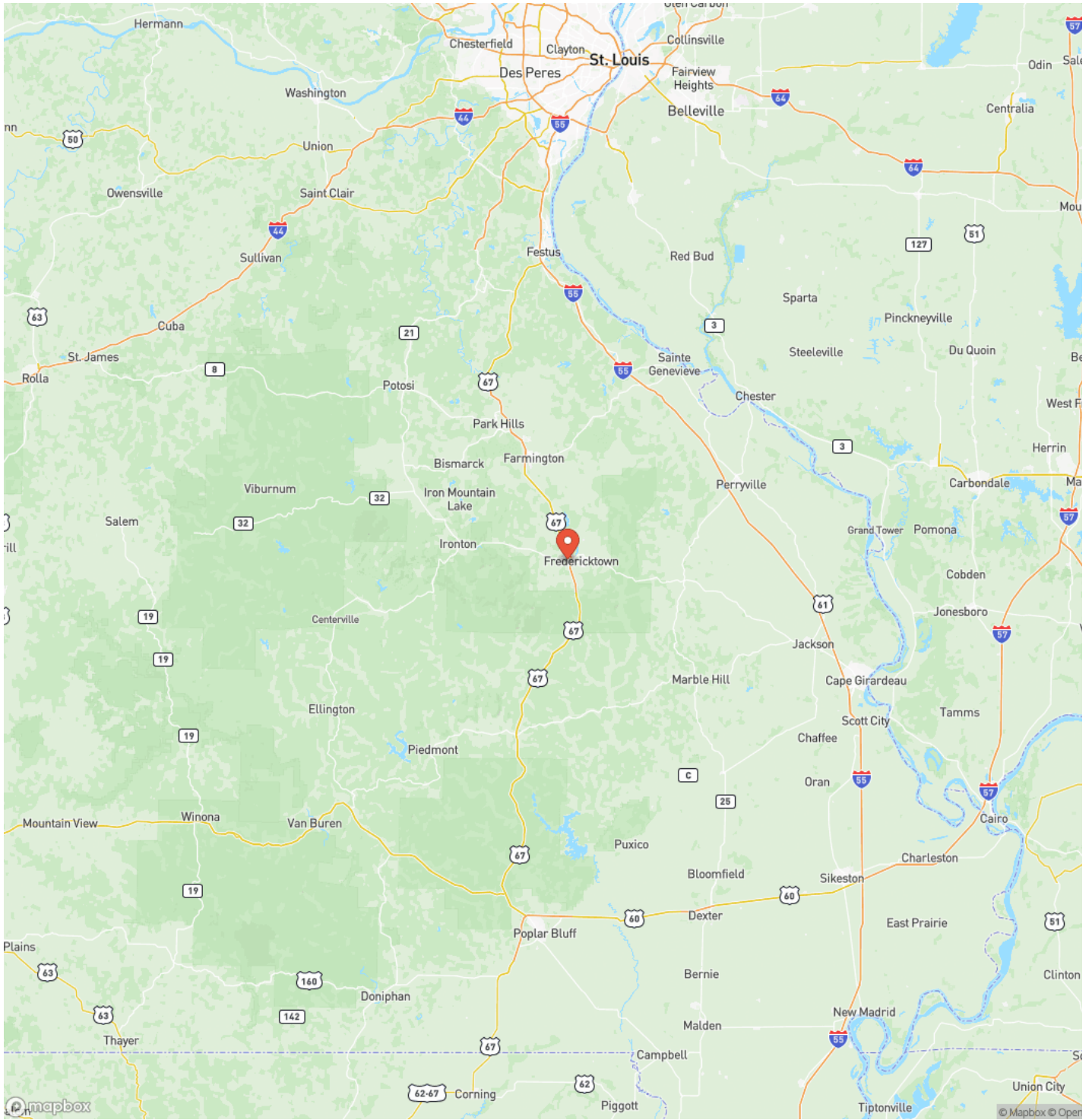

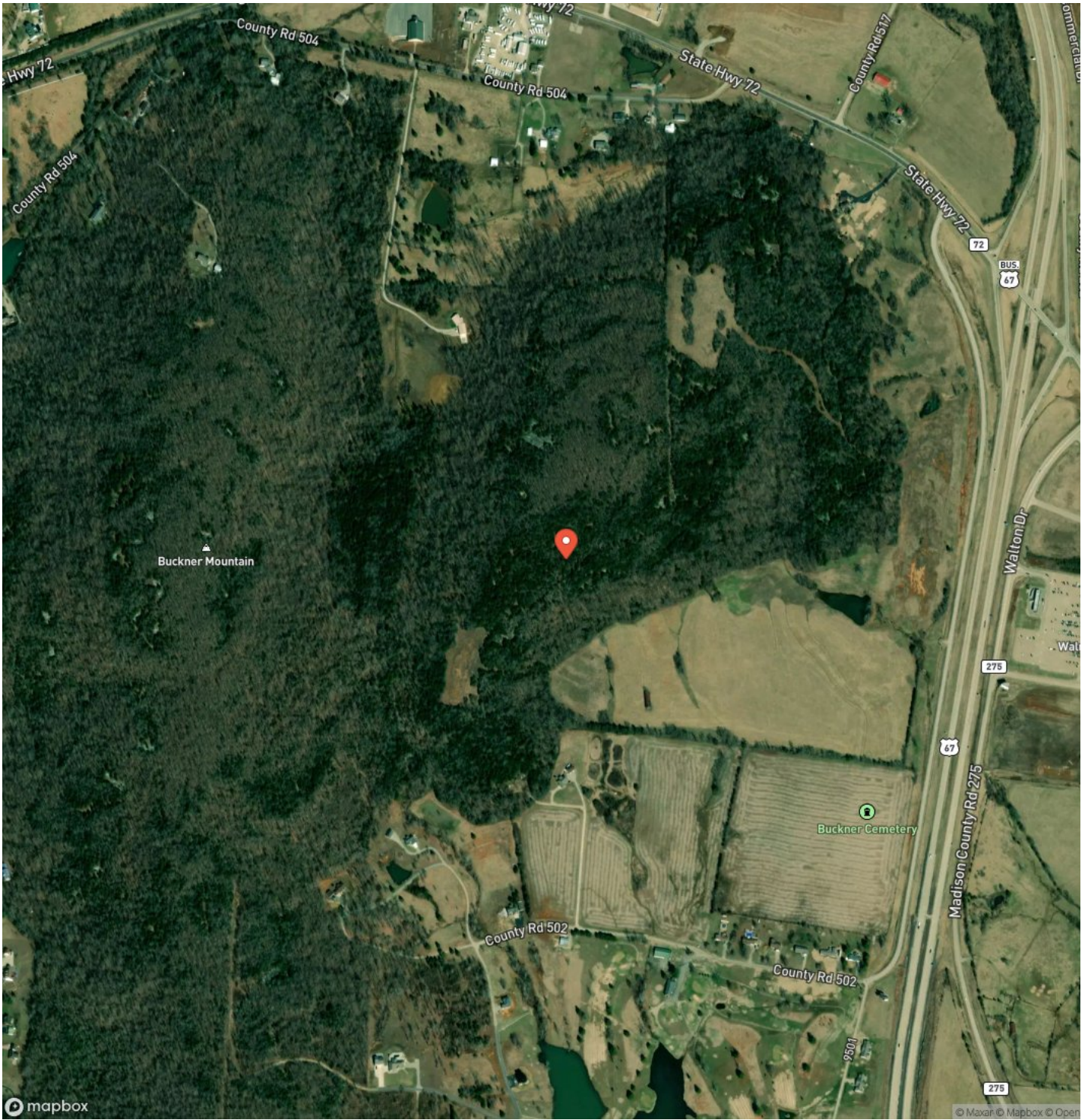
