Only minutes outside of Red Bluff, in the midst of Tehama County cattle and orchard country, and in the Williamson Act for lower taxes. A great place to settle down as a family, downsize to a quiet retirement with room for guests, use as a weekend retreat, or keep for income!

  - Keep for income with two houses and plenty of room for a cattle lease






## Locator Map


